# Introduction

CocoaAction Brasil, an initiative of the World Cocoa Foundation (WCF), works with the Brazilian cocoa chain since 2018 by promoting partnerships and connections, fostering dialogue, creating projects and collaborating for the sustainable development of the sector.

This report aims at assessing the perception about the initiative's impacts among the different segments of the cocoa chain, and understanding progress and evolution over recent years, in which cocoa once again gains relevance and shows its potential for the bioeconomy.

This report will present the different perceptions regarding CocoaAction Brasil's performance over the last 5 years (2018 to 2022) through qualitative and quantitative data collected in interviews with relevant stakeholders and also through an online survey with members and partners of the initiative, in order to evaluate its activities, impacts and contributions to the development of the cocoa sector in Brazil.





# Methodology

CocoaAction Brasil hired the services of Sense-Lab to perform this work. Sense-Lab collected data, developed the impact perception analyses and created the report assessing the trajectory of the initiative.

Sense-Lab is a B company guided by a purpose whose actions aim at catalyzing and developing different players, whether they are organizations of civil society, businesses, ecosystem energizers or networks that involve representatives of several sectors.

This report uses information obtained from different stakeholders of the Brazilian cocoa chain, including entities, industry, representatives of the private and public sectors, civil society, associations, non-governmental organizations, as well as members of the initiative, partners and participants of its governance. Qualitative interviews conducted by Sense- Lab with 10 key stakeholders of the chain (representatives of companies/ industry, of entities, associations, government and NGO).


Quantitative survey (online form with 30 questions) sent to cocoa chain stakeholders, with a total of 83 respondents.



### **Current context of the chain in Brazil**

Cocoa has regained its priority status in recent years in Brazil, and, despite the challenges, there are numerous opportunities for the sector. As cocoa returns to the agenda both of governments — mainly in the states of Bahia, Pará, Espírito Santo and Rondônia — and of the private sector and organizations, the resumption of the chain has made stakeholders more optimistic, with good perspectives about the future, particularly in relation to increases in productivity and sustainability.

Connection between stakeholders is getting increasingly stronger, which enables collaboration and execution of improvements.



# **Figures of the cocoa chain in Brazil**

CocoaAction Brasil is a comprehensible public-private pre-competitive initiative of the cocoa chain aimed at promoting sustainability with focus on the grower. Launched in Brazil in 2018, it is a unique initiative collaborating to align and develop the cocoa chain, promote knowledge exchange and synergies with existing work so as to improve growers' productivity and profitability, with special attention to sustainability.

CocoaAction Brasil has been working as a backbone organization, enabling a positive environment for the organization of the chain, higher efficiency and improved governance of projects.



# How does an organization help to structure a chain?

CocoaAction Brasil has been working as a backbone organization over the past 5 years.

Backbone organizations are those that support multistakeholder collaboration and seek to generate collective impact. Coordinating several players of a chain demands a huge amount of time and resources to generate engagement, education and alignment toward collective growth.

These organizations are present in different markets, focused on impact and their purpose is to address recurring gaps between the links of the chain and ecosystems.


# **Challenges a backbone organization faces**

## **Incentives for quality improvement, with sustainability**

Since 2021, the Cocoa Sustainability Curriculum has been adopted by the National Cocoa Quality Competition, and by the Cocoa Quality and Sustainability Contests of Rondônia and Espírito Santo states as a selection criterion, a message to markets that quality cocoa is the one produced with socio-environmental responsibility.

## **Support in creation of public policies**

CocoaAction supported the publication of the Normative Instructions of Pará and Rondônia, which enable the recovery of Legal Reserves through cocoa cultivation in agroforestry systems (AFS), in addition to the revision processes of Ordinances in Bahia and Espírito Santo states that regulate the management of cabruca and reinforce its relevance to the preservation of the Atlantic Forest. These measures generate socio- environmental benefits, contribute to generate income for families and stimulate biomes conservation. ## **Higher access to rural credit**

CocoaAction Brasil's articulation with different stakeholders and institutions of the chain, participation in strategic discussions, foment to dialogue and collective solutions have been fundamental to expand cocoa producers' access to credit in recent years.

Coordination of **GT Crédito**, a working group that specifically addresses credit in the cocoa chain, linked with the Cocoa and Agroforestry Systems Sectoral Chamber of the Ministry of Agriculture, Livestock and Food Supply (MAPA). Contribution to improvements of Plano Safra (Crop Plan) 2021 - 2022, based on submissions of the cocoa production chain and advocacy with the Ministry of Economy.





In partnership with ILO, CocoaAction Brasil conducted a collective construction process with the cocoa chain in 2020, involving more than 50 entities of the public and private sectors and civil society, which culminated in the creation of the **Cacau 2030 Strategic Guidelines**, a set of guiding actions aiming at the sustainable development of cocoa production, focused on the promotion of decent labor and better living conditions, launched in 2021.


The Sustainable Cocoa Corridor is a pre-competitive sectoral arrangement for the cocoa chain of Pará that foresees a collective commitment with the development of sustainable agroforestry production and collaboration between public and private sectors toward structuring actions for the chain.


During the structuring phase of the project in 2022, Systemiq and CocoaAction Brasil conducted an extensive process of consultation and validation with chain stakeholders to define strategy, operational model and priority actions to be developed. In 2023, a pilot phase is planned to begin operations and priority programs, which should last 36 months. The main activities to be developed are:

# How is CocoaAction recognized?

Perception from stakeholders and Sense-Lab's impact analysis



With the purpose of analyzing the perception of impact of the actions coordinated by CocoaAction Brasil, 10 stakeholders representatives of the cocoa chain were interviewed and 83 members and partners of the initiative were surveyed (filled a perception questionnaire). Once such players' perceptions were collected, it was possible to do a perception analysis of the initiative's impact to the development of the cocoa chain. This analysis was then divided in the following fields:

By building trust, dialogue and collaboration between the links of the chain, CocoaAction Brasil works to create an enabling environment in cocoa. Over the last 5 years, stakeholders were able to note significant improvement in the relationship between the different segments of the chain, which potentiates collective work and union within the sector to advance with strategic agendas.



#### **Facilitator of positive dialogue** in the cocoa chain:

With an experienced team in the promotion of enabling environments, CocoaAction Brasil is seen as a great promoter and facilitator of dialogue by the main stakeholders of the chain. Many interviewees mention that before the initiative stakeholders did not have positive exchanges or even any dialogue at all.

#### **Enabler and potentiator** of result-generating projects for the chain:

The initiative is seen as an energizing agent of the chain, as it creates synergies and connections between relevant organizations and players that generate new projects or potentiate existing actions, providing relevance for the cocoa chain, generating partnerships and knowledge exchange.





We observe that most stakeholders of the cocoa chain recognize this enabling environment as very positive for the sector's sustainable development, being critical to creating solid bases for growth.






CocoaAction Brasil is seen as a big promoter of the sustainability agenda: the Cocoa Sustainability Curriculum and the Cacau 2030 Strategic Guidelines have been perceived as great benefits brought by the initiative to the chain, so that the sustainability agenda has become increasingly relevant.

The initiative efforts related to the promotion of a sustainable agenda in the cocoa chain are in their early stages, when the bases are being built in order to establish a better flow of knowledge between stakeholders, with tangible results in the long run.




# **Establishment of bases for a sustainable production**

As a backbone organization, CocoaAction Brasil's focus the dissemination of knowledge about sustainability within the chain, and the Cocoa Sustainability Curriculum has been perceived as a reference for cocoa growers, technicians and institutions, comprising good practices of production, environmental and social management. Such knowledge becomes a baseline of sustainability for several actors, collaborating for changes at field-level in the long term.

# 53%

of respondents consider that CocoaAction contributes to the advancement of the agenda of **deforestation** control and promotion of reforestation in Brazil by articulating the cocoa chain.

# 69%

of respondents consider that CocoaAction contributes in a satisfactory way or contributes much to the promotion of agroforestry systems and to the advance of their implementation through trainings, facilitation of dialogue and/or other ways.

Fostering the enabling environment made it possible to improve dissemination of knowledge throughout the cocoa chain: CocoaAction Brasil is recognized by stakeholders as an important agent of knowledge generation and information dissemination through discussion forums, support to studies, organization of technical events, the Cocoa Sustainability Curriculum, among other actions. According to interviewed actors, these actions bring more knowledge to the chain, particularly among cocoa producers.

76% of respondents consider the materials published by the initiative critical or very important.


#### The

Annual Cocoa Forum is considered very important by **81%** of respondents in what refers to union of the chain and knowledge exchange.

Webinars organized by the initiative are considered very important by 77% of respondents.

CocoaAction Brasil is recognized for promoting trainings of high technical level, which increase knowledge about sustainability and decent labor.

The Cocoa Sustainability Curriculum and GTec Cacau are seen as important efforts to generate knowledge in the chain.



## **Advocacy with government**

CocoaAction is recognized for "bringing cocoa back" to the agenda of governments and institutions: advocacy with the government is mentioned many times by the interviewees as a strength of the initiative, since the cocoa chain regains its protagonism, being more valued by governments in view of the relationship and articulations coordinated by CocoaAction Brasil in different spheres, at the federal and state levels.

CocoaAction Brasil is recognized by its advocacy efforts to bring cocoa back to the agenda of government.



CocoaAction Brasil is also recognized as a facilitator of credit access increase to cocoa growers: through collective and coordinated work with the chain, financial and banking institutions, growers today have much more access to credit facilities. The initiative contributed to the creation of new credit lines, and helped to mobilize and "unlock" investments for cocoa producers.



#### **CocoaAction's level of contribution to improvement in** credit access to cocoa growers






# **Promotion of Decent Labor**


CocoaAction Brasil is recognized for the strong agenda in the promotion of decent labor, which has been considered an axis of the initiative's performance. All interviewees recognize that there have been improvements in the understanding of the labor legislation and of the conditions to improve living and working conditions in the cocoa chain, given that extensive discussions, workshops as well as reflections about the theme have been promoted.



Cacau 2030 Project is recognized as one of CocoaAction Brasil's major contributions to the chain. This work gathers dozens of partners, including funding and implementing partners, and complementary lines of action that seek to advance with sustain ability at field-level in a tangible way. The initiative's role was to mobilize and engage the different players and partners, facilitate the conception and coordination structure of this broad project, which was perceived as successful by the chain. CocoaAction Brasil is now expected to help actors in the implementation of all planned actions.


## **Conclusions about the perception survey - 2018 to 2022**

The initiative is recognized for the creation of an enabling environment that connects the different segments of the cocoa chain and their agendas in order to facilitate development.







### **The Negative Spiral**


As a result of the destructuring caused by the witches' broom, the Brazilian cocoa chain entered a negative spiral cycle in which the producer lost productivity, production volumes and investment capacity fell, which created a cycle of poverty: if there is no investment, there is no production, there is no credit available, plants get weak and produce less, there are no resources, there is no investment...

This cycle lasted for over two decades. The environment was marked by permanent conflicts, low cooperation, lack of partnerships and failure in the long term.




#### The Positive Spiral and future evolution of the cocoa chain

With the reestablishment of an environment that encourages trust between players, with promotion of dialogue and cooperation, a process of establishment of partnerships has resumed.

New projects started to provide technical assistance to growers (in expansion), credit consistently increased over the last years, and significant investments are currently being made.


As a result, productivity starts to increase among growers who have access to these services, who also start to recover their investment capacity. By adopting agricultural practices that lead to higher production volumes, producers become more profitable, and investment capability increases. The spiral is then inverted to become positive, and it has been gaining traction and speed.

#### **Crawling phase:**


improvements occur, but they are slow and almost imperceptible (phase in which the Brazilian cocoa chain currently is)

Inverting the spiral requires much activation energy, high investments are needed and, at the beginning improvements are almost imperceptible, slow and gradual.

At the beginning, the process is comparable to crawling, when improvements slowly happen. With the latest advancements, the chain is entering the walking phase, structuring itself to achieve the running phase in the future, when fast changes occur.

Despite the huge challenges and the long path ahead, the cocoa production chain in Brazil offers gigantic opportunities to retrieve growers' profitability, aligned with environmental preservation and decent labor.

The spiral is already feeding itself in a dynamic process that has all of the conditions to speed up and become increasingly less dependent of external activation. The result of this process has the potential to be a case of great success in the long term.

# **Opportunities for future actions**

Based on the answers provided in the survey conducted with the production chain, Sense-Lab mapped 6 focal points as opportunities for the next years of CocoaAction Brasil:

Create a permanent culture of collaboration and good relationships, even when chain stakeholders change:

All interviewees agree that the initiative must continue, and that the enabling environment must be kept alive as a permanent culture, as it generates shared value, regardless of replacement of players in this system.

#### Improvements in productivity towards Brazil's self-sufficiency:

Many of the interviewees see self- sufficiency as the greatest goal of the cocoa chain over the next five years and expect CocoaAction to help in this process, by working on several fronts.



Work on the practical implementation of everything that has been discussed, through Cacau 2030 Project:

The Strategic Guidelines are seen as a broad plan of the chain; now stakeholders expect CocoaAction to support its implementation.



# **Opportunities for future actions**

The next steps of the initiative, as the chain envisions it, should include tangible actions to generate transformation at field-level, among cocoa growers.



#### Promote and facilitate the organization of a chain database and indicators:

As there are no consistent and reliable figures, the initiative is expected to promote projects that integrate a database in order to generate more knowledge and technical improvement, which will be able to respond to impact indicators in the future. These could also assist with impact measurement of CocoaAction Brasil itself. Foment more research and technologies capable of generating productivity increase:

For producers to be able to increase productivity, investment in research and new technologies is needed; this has been mentioned multiple times by interviewees as a priority for the coming years.



#### Make Brazil a global reference of sustainable cocoa:

CocoaAction's relationship in several spheres is an opportunity to position Brazil as an important source of sustainable cocoa globally, creating a narrative connected to bioeconomy, environmental conservation, carbon market, among other trends.



# **Sense-Lab's final considerations**

Sense-Lab, which was hired to develop CocoaAction Brasil's Impact Report (2018-2022), worked to explore and systematize the opinions of the initiative's main partners, and presents below its analysis and final considerations of this work.

It has been noticed that CocoaAction Brasil's work as a backbone organization of the cocoa chain over the first five years has been successful. Some of the main contributions that stand out are the construction of a collective vision and of strategic focal points for the development of the cocoa chain, the support and alignment of activities around a common agenda, the encouragement for stakeholders' engagement and collaboration, the management of information and knowledge related to the chain and the facilitation and communication process established with the various actors. In addition, CocoaAction Brasil is recognized for bringing cocoa back to the governmental agenda and for directing efforts to leverage investments to the chain, promoting progress in a sustainable and lasting way.

Partners' expectations in regard to the new cycle of CocoaAction Brasil focus on the implementation of Cacau 2030 Project at field-level and on the pursuit of tangible results.

We conclude that the last 5 years of the initiative's work have been fundamental to creating solid bases for the evolution of the cocoa chain, and that, based on the structuring advances achieved, particularly the strengthening of relationships between its links, it will possible to achieve even more concrete environmental and socio-economic results over the next cycle.
